
## CERTIFICATE

The inspection of building of Greenland Public. School Kandrori Road Surajpur Near Damtal, Tehsil Indora, Distt. Kangra (HP) was conducted by the Assistant Engineer, Badukhar Sub Division, HPPWD, Badukhar accompanied with Junior Engineer in charge. On the basis of their inspection report, it has been found that no Earthquakes resistant norms have been adopted for the concerned School building. No structure drawing has been approved by the competent Govt. agency produced by the School authority. The structure is a non Engineer structure. Hence the structural safety of this building can't be ensured specially from Earthquake point of view. This Department will not be responsible for any type of loss of life and property etc. if this structure fails under any circumstances. However, as per visual inspection, the building appears to be safe in appearance and accordingly the School Building Safety Certificate is being issued by this Department from 1.4.2025 to 31.3.2026. This Department could not access the structural safety of building as the same was not constructed under the supervision of this Department.
